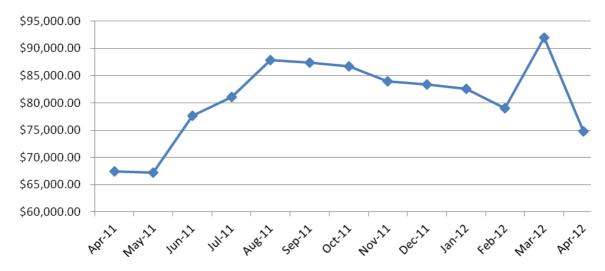

Public Facilities Revenue Fund



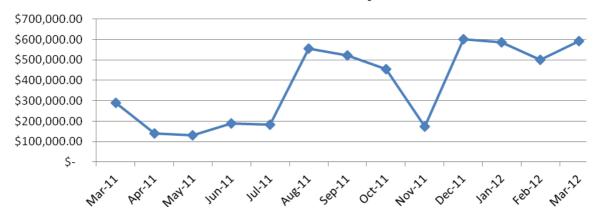
